YOU'RE INVITED Construction Open House



The Florida Department of Transportation (FDOT) invites you to attend and participate in a Construction Open House for the I-75 / Big Bend Road Interchange Improvements Project in Hillsborough County.

The project includes:

- adding a new entrance ramp to northbound I-75 from westbound Big Bend Road
- adding a new exit ramp from southbound I-75 to westbound Big Bend Road
- increasing the storage area at the base of the northbound I-75 exit ramp by adding a left turn lane onto westbound Big Bend Road
- adding a signalized triple right-turn lane from the southbound I-75 exit ramp to eastbound Big Bend Road
- adding signalized, dual left-turns from westbound Big Bend Road to southbound I-75 and eastbound Big Bend Road to northbound I-75
- widening Big Bend Road between Covington Garden Drive and Simmons Loop from a four-lane divided road to six lanes featuring enhanced pedestrian, bicycle, and bus facilities
- rebuilding the Old Big Bend Road and Big Bend Road bridges


