Re: Construction Open House - In-Person and Online  
I-275 Capacity Improvements from north of I-4 to north of US 92 (Hillsborough Avenue)

The Florida Department of Transportation (FDOT), District Seven, invites you to attend and participate in a Construction Open House for capacity improvements on I-275 from north of I-4 to north of US 92 (Hillsborough Avenue) in Hillsborough County, Florida. The Open House will be held on **November 4, 2021**. There will be no formal presentation; therefore, we encourage you to participate at your convenience at the locations and hours listed below. Staff will be available to answer questions in-person, online and by phone from 11:00 a.m. to 1:00 p.m. and from 5:00 p.m. to 6:30 p.m.

The project includes adding one lane in each direction on I-275 from north of I-4 to north of Hillsborough Avenue (US 92). Other improvements include constructing noise barrier walls along most of the corridor, installing Intelligent Transportation System (ITS) devices, and reconstructing the underpasses at Floribrasca Ave., Lake Ave., Dr. Martin Luther King Jr. Blvd., Chelsea St., Osborne Ave., and Hillsborough Ave. to provide wider sidewalks and bright underdeck lighting. All improvements are being completed within the department's existing right-of-way.

To allow for maximum participation, the Construction Open House will be held in two formats including an online virtual tour and at an in-person drive-thru location. Project staff will be available to answer questions as part of the virtual and drive-thru open house as well as by phone. Information presented will be identical at the virtual tour and in-person location.
