



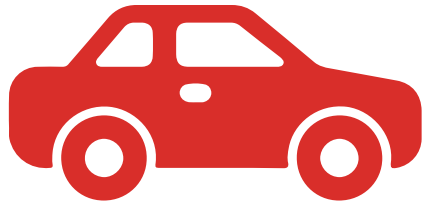

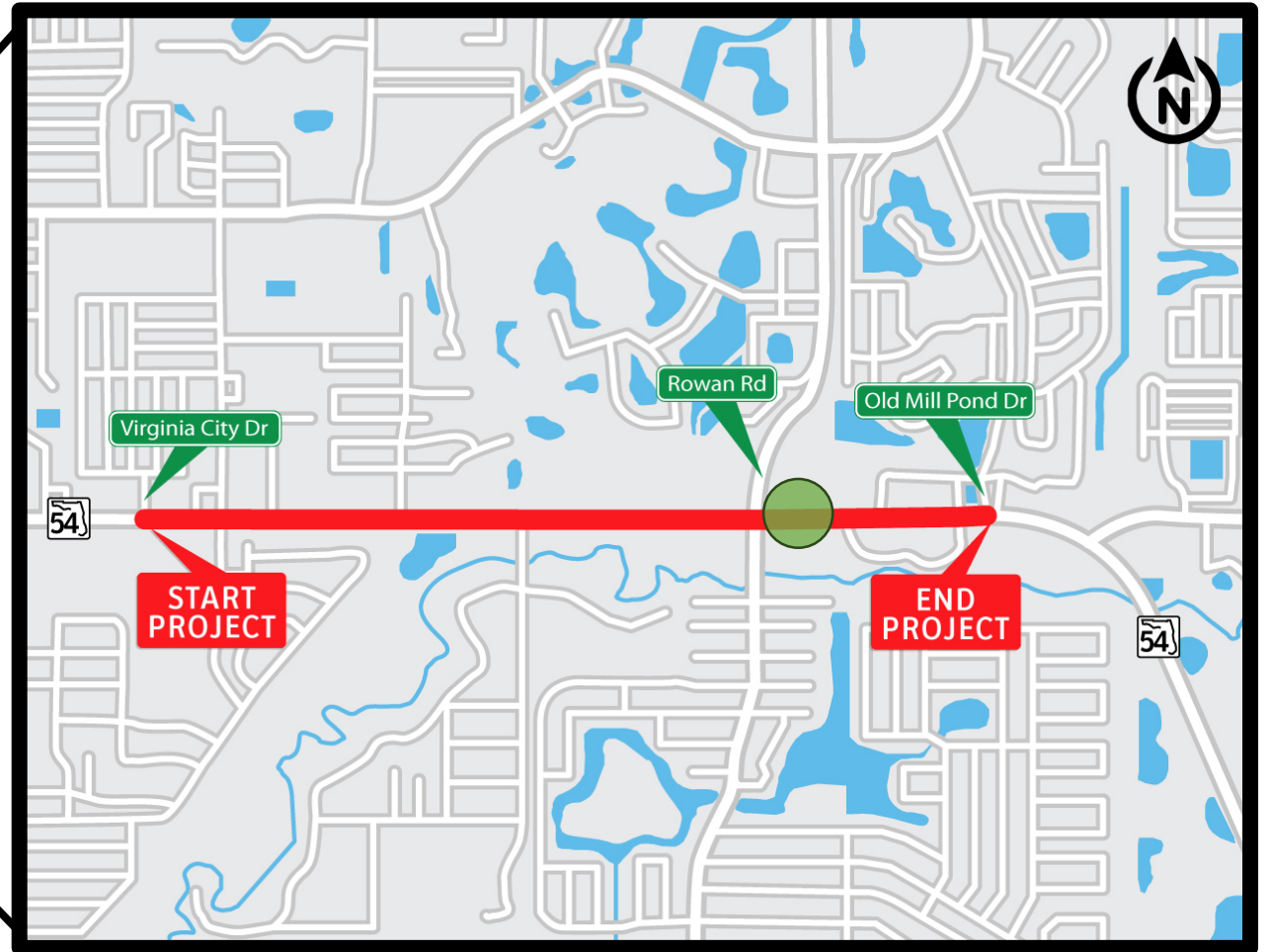
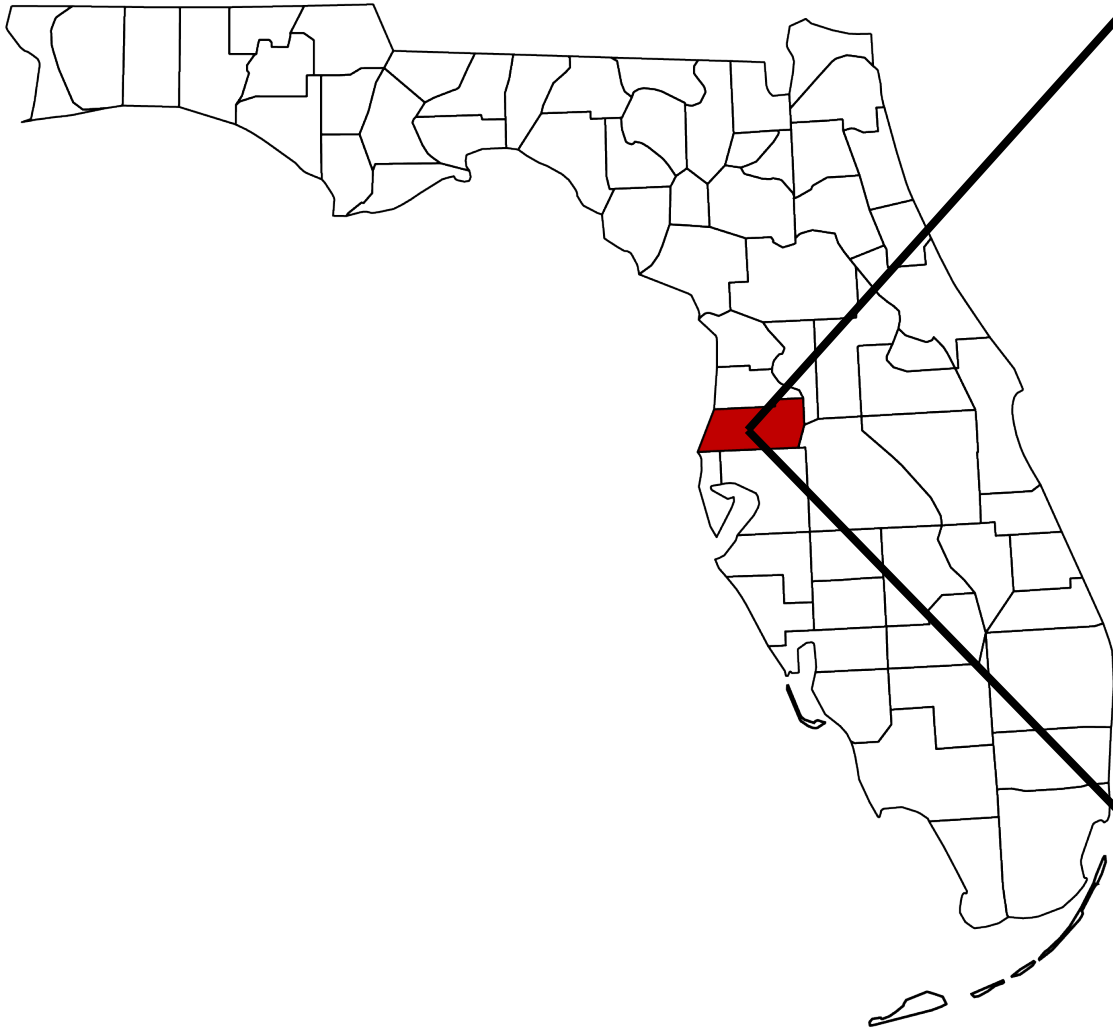

FDOT is holding a **public meeting** to allow affected property owners, business owners, interested persons and organizations the opportunity to **provide comments** regarding the proposed changes.



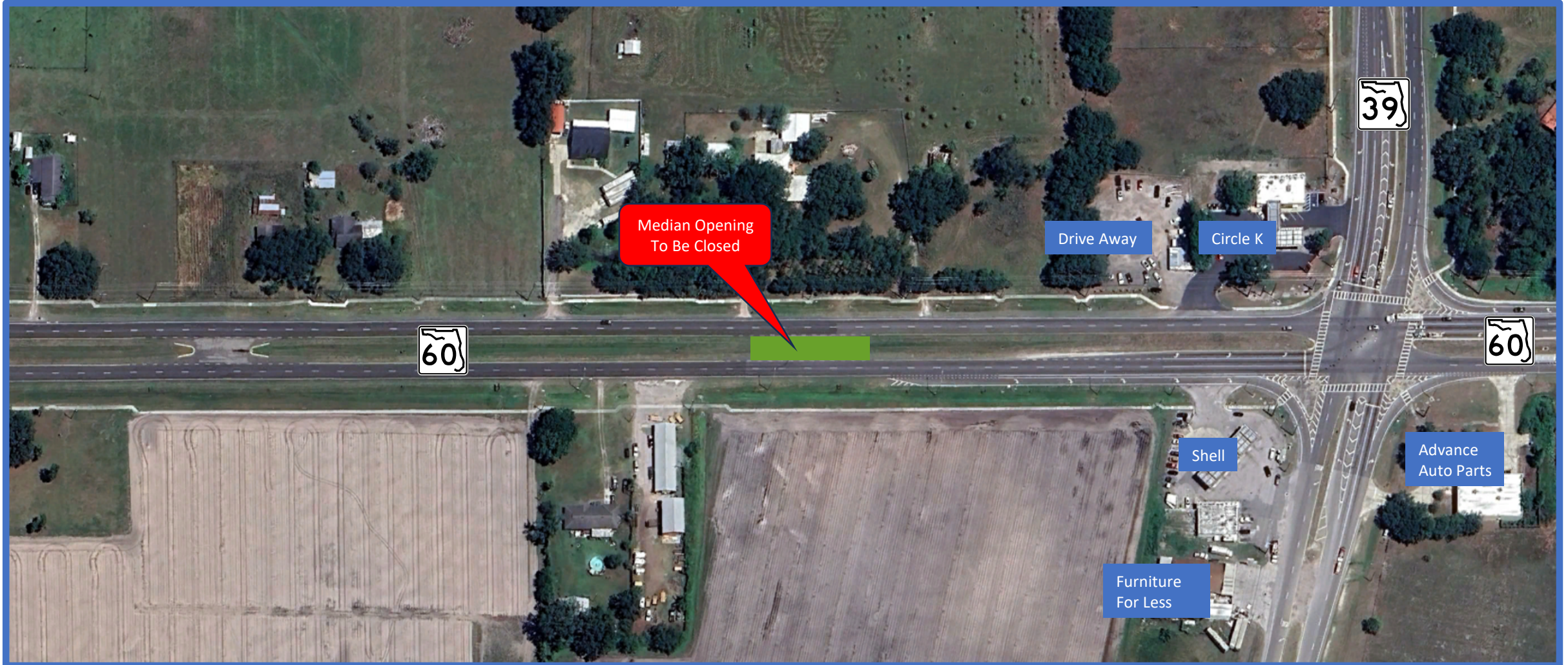
Project Location and Description

Proposed U-Turn Movements – East of SR 39



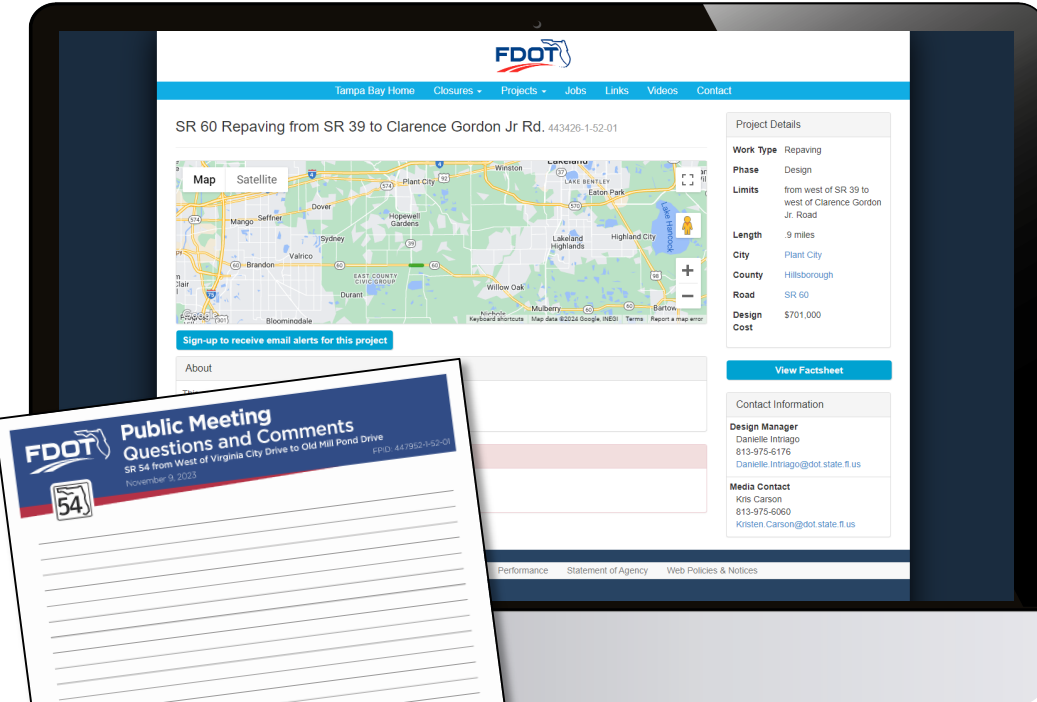
