

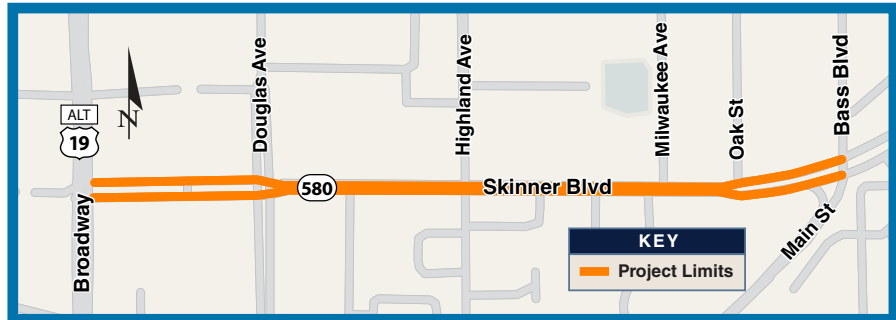
# You're Invited

The Florida Department of Transportation (FDOT), District Seven, invites you to participate in a Public Meeting about proposed improvements to SR 580/Skinner Boulevard from Alt 19/Broadway to Main Street/Bass Boulevard as part of a complete streets project. The proposed project includes:

- Lane reduction from four to two lanes between Alt 19/ Broadway and Oak Street
- Roundabouts at Douglas Avenue and Highland Avenue
- 10-foot wide concrete sidewalks connecting to the Pinellas Trail
- On-street parking/bus bays and bicycle lanes
- Adding a permanent pedestrian crossing signal at the Pinellas Trail
- New mast arm signal Bass Boulevard/Main Street
- Decorative street lighting
- Raised median (landscaping opportunity)
